This narrative history of a Residential School was researched and produced by the Government of Canada as part of its response to litigation and the Indian Residential Schools Settlement Agreement. The National Centre for Truth and Reconciliation has not verified the content of this document. It is provided here for reference purposes only. Documented incidents of sexual and physical abuse are based on the documentary record and do not take into account survivor testimony.

DOCUMENTS REFERRING TO SCHOOL INCIDENTS

To date, we are unaware of any convictions for abuse at Brandon IRS or of any convicted abusers present at Brandon IRS.

The following suggestions of abuse, listed chronologically, comprise all known identifiable complaints and/or allegations received by government officials and all available information regarding the follow-up and outcome.

Incidents (Sexual)

Incidents (Physical)

- A 17 year old former student was charged with unauthorized entry into the IRS. The document mentions the boy's improper conduct including "carnal knowledge". He was subsequently convicted in juvenile court of breaking and entering, and was sentenced to spend one additional year at the Portage la Prairie Industrial School [BRS-000216; BRS-000217; BRS-000219].
- A federal inspector noted that while the IRS Principal uses the strap for punishment, the Principal denies hitting pupils with his fist [BRS-000251].
- Letter expressed concern that children at the IRS were mistreated and did not get enough to eat [BRS-000244].
- A local Member of Parliament had received a complaint that the children at the IRS were not fed or clothed properly [BRS-000492-0000; BRS-0000492-0001]. The federal government replied that reports on the Brandon IRS indicated it "continues to be capably managed under the auspices of the United Church of Canada" but that an Inspector would be visiting the IRS in the near future and would rectify matters, if necessary [BRS-000494; BRS-000493-0000; BRS-000493-0001; BRS-000495; BRS-000496].
- Two anonymous letters of complaint received by the RCMP alleged that students were badly under-nourished, and truant students were severely beaten before being returned to the IRS [BRS-000509-0000; BRS-000509-0001; BRS-000510].
- 1946, 1947 A letter from a federal government Inspector referred to sworn statements submitted by two parents regarding the alleged mistreatment of their children by the IRS Principal. The Inspector suggested that the statements be investigated, as he had received other complaints of a similar nature about the action of the Principal, "and perhaps it is an explanation of the numerous cases of truancy at this school" [BRS-000523; BRS-000525]. Please note that the sworn statements were not found.
- A student told an Inspector that the IRS Supervisors were "sometimes rough with boys" [BRS-000882].
- Two parents had heard that their children were being mistreated at the IRS and wanted to remove them from residence [BRS-003661].

Incidents (Student on Student)

A father complained that the Principal was not "looking after things" and that some of the children were "very mean to the little ones and the reason is the staff aren't with them enough to see to these things, and they are not getting enough to eat". The letter also mentioned a boy who froze his feet while running away from the IRS the previous winter. The father asked to keep his child at home and send him to a day school [BRS-000944].

The Superintendent of the Pelly Indian Agency wrote that parents refused to send their young boys to the Brandon IRS because the boys were not supervised outside the classroom and that "the little boys were much abused and knocked about by the older boys and if they complained to their teacher, it only resulted in more abuse from the older boys" [BRS-001022].

ADDITIONAL INFORMATION

- A nurse reported that throughout the year at the IRS there were three deaths from tuberculosis, five cases of pneumonia, thirty six cases of measles, fifteen cases of grippe and that all "of these pupils had to be kept in the dormitories" [BRS-000209]. The federal government recommended that all pupils should have their own bed and sick children should not remain in the dormitories [BRS-000210].
- The federal government noted concern over the numerous reports of truancy received from the Royal Canadian Mounted Police and requested that the Principal "remove any friction that may be causing the pupils to truant" [BRS-000483; BRS-000485; BRS-000489-0000].
- A child was accidentally run over by a tractor and died [BRS-000331-0000; BRS-000330].
- The federal government received a complaint from "a reliable source that a deplorable condition" existed at the Brandon IRS with respect to the quality and quantity of meals served to the children [BRS-001001; BRS-000964].
- The Principal informed the Board of Home Missions of the United Church that he discharged one of the Supervisors, as he found her to be "quite odd and peculiar in her actions" and was "found on many occasions to be in a trance-like attitude, her control of the children…practically nil…" [BRS-000632].
- On February 18 it was reported that there had been 50 cases of an infection virus that was originally thought to be measles. Ten children became very ill with a repeat infection and the Principal suggested having a doctor make weekly visits [BRS-003662].
