This narrative history of a Residential School was researched and produced by the Government of Canada as part of its response to litigation and the Indian Residential Schools Settlement
Agreement. The National Centre for Truth and Reconciliation has not verified the content of this document. It is provided here for reference purposes only. Documented incidents of sexual and physical abuse are based on the documentary record and do not take into account survivor testimony.

The IRS operated temporarily in rented facilities in the town of Elkhorn until the new IRS building opened on September 7, 1899 [ELK-000440, pg. 2; ELK-000436, pg. 9, 22; ELK-000445, pg. 2; ELK-000551, pg. 25-27]. The IRS operated until May 1, 1918, when it closed due to a lack of agreement between the Anglican Church and the federal government regarding financial responsibility [ELK-000249; ELK-000468, pg. 6; ELK-000250]. DOCUMENTS REFERRING TO SCHOOL INCIDENTS

To date, we are unaware of any convictions for abuse at the Elkhorn IRS or of any convicted abusers present at the school.

The following suggestions of abuse, listed chronologically, comprise all known identifiable complaints and/or allegations received by government officials and all available information regarding the follow-up and outcome.

Incidents (Sexual)

Incidents (Physical)

A federal Inspector reported that a visiting Nurse at the IRS made allegations that the boys' supervisor mistreated the children. The IRS Principal denied the claim [ELK-000330].

The Chief and a Councillor from The Pas Band complained about conditions at the IRS: poor clothing, head lice, and inadequate food. They also alleged that a boy was punished and not fed for two weeks, and that a female pupil's feet froze and had to be amputated. A federal Inspector visited the IRS to investigate the allegations. He noted that two girls who ran away from the IRS suffered frostbite and a boy was punished by the IRS Principal and sent to bed without supper. The Inspector suggested ways to improve the conditions at the IRS [ELK-000082; ELK-000419; ELK-000085].

Incidents (Student on Student)

No information found.

ADDITIONAL INFORMATION

The farm used by the IRS was on 640 acres owned by the federal government, and was located four miles away from the IRS buildings [ELK-000047; ELK-000070; ELK-000431, pg. 3].

A federal Indian Agent reported numerous complaints from parents of residents at the IRS regarding sickness, poor nutrition and lack of sufficient clothing. One parent alleged that one of her children died and she was not notified by the IRS that her child was sick [ELK-000326; ELK-000331; ELK-000332].

There was a measles epidemic at the IRS in January 1936 [ELK-000551, pg. 85].

There was an influenza epidemic at the IRS [ELK-000551, pg. 101].

Parents complained that conditions at the IRS were very poor. A federal inspection report noted that IRS was in bad state and that parents had good reason to complain [ELK-000392-0000; ELK-000381; ELK-000395; ELK-000399-0000; ELK-000399-0001; ELK-000400].

A grandmother of pupils at the IRS complained about inadequate food at the IRS [ELK-000406-0000; ELK-000406-0001].
