This narrative history of a Residential School was researched and produced by the Government of Canada as part of its response to litigation and the Indian Residential Schools Settlement Agreement. The National Centre for Truth and Reconciliation has not verified the content of this document. It is provided here for reference purposes only. Documented incidents of sexual and physical abuse are based on the documentary record and do not take into account survivor testimony.

The Federal Hostels at Payne Bay were located in Payne Bay, Quebec, in the region known as Arctic Quebec [GWR-000233-0002, pg. 1, 3].

OPERATING DATES AS AN INDIAN RESIDENTIAL SCHOOL

These dates represent the time during which the Government of Canada was responsible for the operation of the Indian Residential School, excluding any periods of closure.

October 3, 1960 to June 30, 1962

OPERATING DATES CONTEXT

The Federal Hostels at Payne Bay were operated solely by the federal government [PBH-000108; PBH-000107; PBH-000121]. The two hostels opened on October 3, 1960, and they were used primarily by children whose parents were away on the trap lines [PBH-000099; PBH-000086-0001, pg. 1, 7]. Most of the residents were discharged by February 21, 1962 as the hostels had closed. Four pupils remained and boarded with the Payne Bay Federal Day School teacher/Acting Principal, who resided in a hostel building during this time. The hostels did not re-open after the 1961/62 school year [PBH-000121; PBH-000120; PBH-000118].

RELIGIOUS AFFILIATION

The Federal Hostels at Payne Bay were non-denominational.

1960 In December, pupils left the hostels for approximately two weeks to return

with their parents to their camps for Christmas vacation [PBH-000086-

0001, pg. 7].

1960/61 The teacher at the Payne Bay Federal Day School, who supervised the

hostel staff, wrote that a hostel supervisor was unkind to the children and unqualified for the job. After three months the teacher fired the hostel supervisor and hired the woman's sister for the position. Conflict between the new hostel supervisor and the supervisor of the second hostel ensued. The teacher had all of her meals, except breakfast, with the children, to help "strengthen the relationship between us and build up good habits." The teacher noted that despite problems with hostel help, the hostels were successful and the children were happy [PBH-000086-0001, pg. 4-10].

PRINCIPALS/ADMINISTRATORS

There were no Principals or Administrators at the Federal Hostels at Payne Bay. The Hostels were instead administered by teachers and hostel supervisors.
