This narrative history of a Residential School was researched and produced by the Government of Canada as part of its response to litigation and the Indian Residential Schools Settlement Agreement. The National Centre for Truth and Reconciliation has not verified the content of this document. It is provided here for reference purposes only. Documented incidents of sexual and physical abuse are based on the documentary record and do not take into account survivor testimony.

DOCUMENTS REFERRING TO SCHOOL INCIDENTS

To date, we are unaware of any convictions for abuse at the Fort Frances IRS or of any convicted abusers present at the school.

The following suggestions of abuse, listed chronologically, comprise all known identifiable complaints and/or allegations received by government officials and all available information regarding the follow-up and outcome.

Incidents (Sexual)

1920

An R.C.M.P. report indicated that on more than one occasion the Principal had made indecent proposals to pupils. As a result, the Principal was relieved of his religious duties, but remained as Principal of the IRS [FFR-000148-0000; FFR-000148-0001].

Incidents (Physical)

No information found.

Incidents (Student on Student)

No information found.

ADDITIONAL INFORMATION

IRS pupils were largely from the following Bands: Couchiching, Seine River, Black River, Manitou, Standjicoming (Stangecoming), Red Cut, Assabaska, Whitefish Bay, Naicathcewenin, Whitesand, Sabaskong, and Lac Seul [FFR-002668; FFR-002679; FFR-002711; FFR-002721; FFR-000042; FFR-002754].

1912	A male IRS pupil died of consumption [FFR-002816, pg. 17].
1913	Two siblings enrolled at the IRS died at their home as a result of tuberculosis [FFR-002817, pg. 19].
1932	The Principal terminated the employment of the IRS night watchman due to "misconduct and carelessness" [FFR-000234-0000; FFR-000234-0001].
1951	A hockey tournament took place in Kenora and involved teams from the following Indian Residential Schools: Fort Frances, Cecilia Jeffrey, McIntosh, Kenora (St. Mary's), and Sioux Lookout (Pelican Lake) [FFR-001848].
1953	A Fort Frances IRS student was admitted to a hospital and died. The

cause of death was not provided [FFR-001796].

1958 to 1963 When necessary, the IRS Principal placed students in private homes for the summer, rather than keep them at the IRS. The room and board expenses related to the summer placements of students were an operating cost of the IRS [FFR-000369; FFR-000427; FFR-000429; FFR-000467-0000; FFR-000467-0001].

May 1963 The Children's Aid Society learned from the IRS Principal that runaway incidents from the IRS had reached "serious proportions" in the last year. The federal government investigated the matter and reported in August 1963 that the IRS had occasional runaways. The Principal noted that running away had become popular amongst students, and those who did not participate were ridiculed [FFR-000461-0001; FFR-01547; FFR-000460; FFR-000464].

In September, the federal government requested that the R.C.M.P. investigate a former IRS Principal regarding allegations that he had committed fraud in relation to payments received from the IRS' fuel supply company. In March, the federal government decided not to pursue the allegations [FFR-000633-0000; FFR-000633-0001; FFR-000634; FFR-000635-0000; FFR-000635-0001; FFR-000637; FFR-000638-0002; FFR-000664-0000; FFR-000664-0001; FFR-000649-0002].
