Document also notes that there is a "rather serious epidemic which has affected 19 boys of various ages. This may turn out to be tuberculosis..." [GUY-000129a]

Nineteen boys of all ages are in bed from an unknown sickness [GUY-000133f]

1958 Water at new school is contaminated and "found to be dangerous as it contains bacteria usually found in sewage" [GUY-000336]

1959 Water at school is still unhealthy to consume [GUY-000345a]
