#### **DOCUMENTS REFERRING TO SCHOOL INCIDENTS**

To date, we are aware of one conviction for physical abuse at the Mohawk IRS.

1913/14

Two former residents charged the Principal for cutting off their hair, imprisonment, provision of bad food, and one resident also alleged he was liable for a whipping received at the IRS. The case was tried on March 31, 1914, and The Brantford Expositor reported that the Principal was fined and damages of \$400.00 were awarded for two of the claims. The claims for whipping and imprisonment in a cell were upheld [TAY-001777; TAY-001778; TAY-001779; TAY-001780; TAY-001781-0001; TAY-001800; TAY-001782; TAY-001783; TAY-001788; TAY-001797].

The following suggestions of abuse, listed chronologically, comprise all known identifiable complaints and/or allegations received by government officials and all available information regarding the follow-up and outcome.

#### Incidents (Sexual)

No information found.

## Incidents (Physical)

Mohawk Institute IRS

- A lawyer lodged a complaint on behalf of an IRS resident, regarding a staff member allegedly punishing the student so harshly that his body was covered in bruises. Though the federal government was critical of the staff member's handling of the situation, it was determined that the strap in question could not have been responsible for the noted bruising. The teacher who administered the punishment stated that the pupil was struck with the strap four times on each hand [TAY-003111-0000; TAY-003111-0001; TAY-003112; TAY-003113; TAY-003114; TAY-003116-0000; TAY-003117-0002; TAY-003118; TAY-003119; TAY-003120-0000; TAY-003120-0001; TAY-003121; TAY-003122].
- 1951 Complaints from parents regarding insufficient food, too much corporal punishment, and harsh treatment of the children at the Mohawk IRS were investigated. A representative from the Church stated that conditions at the IRS were fine with respect to food and clothing, but discipline was stricter than at other Indian Residential Schools [TAY-001338; TAY-001339].
- A parent complained about her daughter's strapping by the Mohawk IRS Principal. It was reported that upon examination, there were no marks on her arms and shoulders. The Principal said that he gave her two strokes of the strap for misbehavior. The girl and her sibling were discharged from the IRS [TAY-000453].
- A former IRS pupil from 1942 to 1947 described his experience at the IRS as one fraught with disgraceful food, beatings, and other mistreatment at the hands of the IRS staff. The former pupil noted witnessing Indian children having their face rubbed in human excrement and urine as punishment for bed wetting [TAY-001046].

#### Incidents (Student on Student)

- 1942 to 1947 A former pupil at the Mohawk IRS stated that the older boys bullied the younger boys, who were like "slaves". The former pupil also noted that younger boys were forced into "homosexual contact" by older boys [TAY-001046, pg. 3].
- It was reported that a staff member caught two boys "in the act of homosex." Two older pupils had restrained a younger pupil while the remainder of the boys in the dormitory reputedly watched. Subsequent correspondence included guidelines for administering corporal punishment and measures that could be taken to improve living conditions at the Mohawk IRS [TAY-000349, pg. 2; TAY-000350; TAY-000358].
- A Mohawk IRS student was allegedly caught stealing and had caused a car accident while away from the IRS. A report also stated that the student was later caught with a twelve year old female student on one occasion, and had also "been chased out of the smaller boys' beds" on other occasions [TAY-002250-0000; TAY-002250-0001; TAY-002250-0002].

## **ADDITIONAL INFORMATION**

- Three deaths occurred during 1902, one from acute Bright's disease, one from pneumonia and one from congestion of the lungs [TAY-004435, pg. 3].
- Over 40 cases of the measles and the grippe occurred at the IRS in January and February. One student died from bronchial pneumonia [TAY-004440, pg. 4].

Pupils who could not return home for the summer holidays were sent to the Huron Church Camp in Bayfield, Ontario. The ten-day camp was affiliated with the Anglican Church [TAY-000897; TAY-000898].
