This narrative history of a Residential School was researched and produced by the Government of Canada as part of its response to litigation and the Indian Residential Schools Settlement Agreement. The National Centre for Truth and Reconciliation has not verified the content of this document. It is provided here for reference purposes only. Documented incidents of sexual and physical abuse are based on the documentary record and do not take into account survivor testimony.

# Last updated October 30, 2012 Incidents (Physical)

A father pulled two of his children out of the IRS following an incident in which he alleged that the Sister Superior slapped both children across the face in front of him. A follow-up investigation was conducted by the federal government in which the Sister Superior gave her account of the situation. The Sister stated that she had held one of the boys back by the arms when he tried to leave the IRS with his father, and when the boy yelled out, she covered his mouth with his own hand [THR-000219-0000; THR-000219-0001; THR-000225-0000].

A former Superintendent of Education official with the Department of Indian Affairs, Saskatchewan, wrote a paper on the Thunderchild IRS that alleged incidents of severe physical abuse (including that a boy had been beaten to death by IRS staff) punishments, poor and insufficient food, and sickness at the IRS. An RCMP investigation into the alleged death of a child through beating concluded that the child died of pneumonia [THR-000251-0000; THR-000251-0001; THR-000252-0000].
